















Economic growth and the composition of GDP












Yield curve GTM - u.s. | 31






U.S. corporate debt outstanding and dealer inventories USD billions



U.S. investment-grade corporate bond trades USD millions (LHS); # of trades (RHS)




Liquidity Cost Score (LCS) for different bond markets % score, May 2019








International equity earnings and valuations







Other asset classes:

The **Alerian MLP Index** is a composite of the 50 most prominent energy Master Limited Partnerships (MLPs) that provides investors with an unbiased, comprehensive benchmark for the asset class.
