McGowan Group Asset Management, Inc. is a Federally Registered Investment Advisory Firm utilizing Pershing LLC, a BNY Mellon Company, for asset custody. In the interest of Full Disclosure and client education for the results of McGowanGroup's advisory services, this composite contains ALL client and employee account results for the entire tracking period since March 31st, 2001.

This report is not GIPS (Global Investment Performance Standards) compliant because: the composite includes different disciplines evolved over the time and the composite includes non-discretionary accounts managed under the advice of Spencer McGowan before the firm converted to full discretionary managed at the end of 2014.

The results fully disclose the broadest possible aggregated results including the value of risk of loss during adverse market conditions.

Results are net after fees and all costs for all accounts. Employee accounts, less than 1% of total assets, received the benefit of no management fees. The advantage of this employee benefit on net after fees performance is less than 1 basis pt. (or .01%) to the actual performance results because of the total size of employee assets in relation to the entirety of MGAM's total assets under management. Only accounts with unpriced securities were excluded from the composite to prevent misleading errors and to ensure the accuracy of results.
